MEETING MINUTES

The Township Board of Washington Township, Marion County, Indiana met at the Washington Township Government Center located at 5302 N. Keystone Avenue, Suite E, Indianapolis, Indiana, 46220 on Thursday, February 23, 2023.

The Board Members present included Emily Denton, David Smith, Emily Gurwitz, Lacy Johnson and Eric Poole. Also in attendance were Frank T. Short, Washington Township Trustee; Beth Marsh, Township Accountant; and Bette Bowman, Township Emergency Assistance Supervisor.

Board President Poole called the meeting to order at 6:05 pm and then led everyone present in the Pledge of Allegiance.
